**LBNC Bylaws Article V Governing Board, Section 6 Vacancies "A**. **Article V Governing Board Section 1 C:** An OSR shall be any person who participates in a religious institution, educational institution, community organization, non-profit organization, neighborhood association, school/parent group, faith based group, senior group, youth group, arts association, service organization, boys or girls club, cultural group, or environmental group within the Council's boundaries.
