7. Announcements and Reports

A. LAPD Officer Olivares

There have been a lot of burglaries from motor vehicles. Officer Olivares discussed the importance of hiding articles away out of sight to prevent thefts. Additionally, the police have been dealing with a lot of people who are mentally ill. There is a program, CAMP, that helps people who are mentally ill who don't want to accept treatment or services. They can be evaluated and put on a hold. Officer Olivares stated he is retiring from the police force in two months, after which he will be a reserve officer.

B. Lauren Padick – Field Deputy, Councilwoman Martinez's Office (CD6)

March is Women's History Month, and an event was put on at City Hall called In Her Words. The Third Annual Spring LA Fire Department Girls Camp (for girls who train under firefighter learning skills) will take place at the Panorama City Fire Station on Saturday and Sunday, April 7th &, 8th, 2018. The new Young Women's Advisory Council out of Councilwoman Martinez's City Hall office is looking for young women who are interested in politics. Contact Lauren for more information. Councilwoman Martinez made a motion asking the City Council to support Assembly Bill AB2343 (dealing with residential evictions) and to have the LAPD do a report on sexual harassment on Metro.

C. Brian Gavidia – Mayor Eric Garcetti's Office (213) 713-0960 Brian.Gavidia@lacity.org
Homeless Connect Day had over 20 service providers and resources at Woodley Park. More
than 100 people attended. In N Out Truck provided food. The mayor is doing homeless events
on a monthly basis. The mayor announced that Los Angeles has the most installed solar power
of any city in America. The Clippers have donated to renovate basketball courts in hundreds of
parks across the City in preparation for the Olympics. The Mayor has appointed a new director,
Christina Miller, as Senior Project Manager for homeless efforts. Brian stated he will be
transitioning from the Mayor's office as of April 20, 2018 to Northeast Valley Health Corporation
as Government and Community Relations Manager.

D. Cara Onofre, Director for Advocacy for LAUSD Kelly Gonez (818) 389-9216

Her office met with Byron Gutierrez to talk about education, and looks forward to cooperating with LBNC. LAUSD is searching for a new superintendent. Stagg Elementary School is now a California Distinguished School Award winner. Stagg has the highest rating it can have. There

will be a picnic in the park to meet Kelly Gonez at the Rec Center in San Fernando on April 7, 2018 from 2:00-4:00pm.

E. Emma Taylor – Field Representative from Assembly Member Adrin Nazarian's Office (District #46) (818) 376-4246

The third annual Chess Tournament is in May 2018. They are expanding it to Lake Balboa elementary schools. Every 6 months they do women's self defense classes, and they are now having 6 classes, April 14-15 and 21-22. Her office has two seismic bills and will present on them to us next month.

F. Semee Park – Department of Neighborhood Empowerment (DONE)

Planning 101 is coming up with the Planning Department on April 9, 2018 at Palms, April 16 at Granada Hills Charter, and April 30 at the Noho Rec Center, all from 6:00 pm to 8:30 pm.

8. Guest Speaker: Kris Freed – Chief Program Officer, Los Angeles Family Housing, 818-255-2743, kfreed@lafh.org

She is the coordinator for this region. LAFH collaborates with everyone and has been doing this since 1983. LAFH is responsible for everything from engaging people on the street to shelters, programs, and real estate development (permanent supportive housing). LAFH has 24 facilities now. LAFH wants to be our partner, and to end homelessness, but it can't be done by government alone. Measure H was a huge help but the money has just started rolling out. There have been 50 years of poor planning and decisionmaking. LAFH is looking for employers and ways to connect people with housing. Families are being pushed out. The expectation needs to be managed. LBNC was invited to come and tour LAFH's facility to see how Measure H is working. Fifty new units of permanent supportive housing have just been opened. Every day people are falling into homelessness. Seniors and families are affected. We have to say it is OK to house homeless people in our backyard. Please come and see our units.

- A. Jon Pelzer He is a 35-year resident and a first-time candidate running for Congress in the 30th CD. His mission on the campaign is universal health care, affordable housing, climate change, special interest money.
- **B.** Lorna Paisley She discussed the problem of litter in the area and stated something needs to be done.

C. Rosie Avetisyan of PESA (Parents Educators Students In Action)

Their organization sponsors the teen court program, where the jurors are high school age and give out minor consequences as punishments. The LAPD is working with them and as of May 8, 2018, will refer their cases to PESA. She stated funding is needed.

10. ANNOUNCEMENTS AND REPORTS: Committee Chairs and Board Members

A. President's Update:

President Linda Gravani announced that at the VANC yearly event in March, Lake Balboa Neighborhood Council was awarded BEST OF for working collaboratively to invest in education for the future of our children. The award was received from the founder and chair Jill Banks Barad, and we received recognition from State Senators Henry Stern and Bob Hertzberg.

The deadline for event approval requests is May 20th. The last day for check payment requests is June 1st. The deadline for credit card payment transactions is June 20. We don't presently know the deadline for NPG's. It takes a great deal of time and effort to get LAUSD and the City Clerk to get together to allow us to rent this auditorium. We have to do it every quarter as if from scratch.

Linda attended the Bertrand Avenue Elementary LEADER IN ME.ORG program and it was phenomenal. She met with Council Member Ryu regarding city funding and the difficulty with LAUSD and DONE. Kelly Gonez's picnic is April 14th. Flyers for the community meeting are being passed out Saturday, April 7th from 2:00-4:00pm at Gault Elementary School. Ethics training must be completed before the next meeting for Jim Hart, James Brown and Sandy Joseph.

B. Education Committee – Byron Gutierrez

LAUSD is on spring break. There is a lull right now. Byron believes in public schools. Elected officials are engaged. Our meeting on the 14th is our big push to get the community involved. Our focus is chess and robots. Our award at VANC is great. We're hoping to expand chess and robotics. If we can get five schools this year and build on that, it will be a good year. We're looking to sponsor a robotics summit, and we want to get more schools involved.

C. Emergency Preparedness – Linda Pruett

The Emergency Preparedness Meeting is Saturday, April 14, 2018 at 9:00am at the Flyaway. The speaker will be Captain Stacy Gerlach of LAFD, the mother of CERT.

D. Health and Public Safety – James Brown

James Brown is meeting with the West Valley LAPD Safety Captain and schools to improve ties with LAPD at all school levels. Every 90 seconds someone dies from cardiac arrest. Starting in August students in public high school must take CPR in order to graduate. On May 8 we'll be training

teachers and others. Training will also take place at Daniel Pearl. James encouraged everyone to take CPR training – he wants more than 1000 people successfully trained this year.

E. Land Use – Tom Riley

The Community Plan is in development in the city of Los Angeles. There is an updated master program that indicates what each community would like to see and what the future of its involvement with the city of Los Angeles is all about. During the Land Use meeting on June 18, a city representative will attend to discuss what has been done and to get input from the public.

The 10K River Run for victims, Movies in the Park, planning for the community meeting on April 14th were discussed at the last Outreach Meeting.

Animal Services - Jennifer Freel

No report was given, as she was not present.

Homeless - Cindy Kurland

There was no meeting this month. Mary Pennomon stated that she was invited to the Sepulveda Basin by Nury Martinez's office about 3 weeks ago. There were 20+ tents there for the homeless with services for job interviews, mental health, veterans' health, housing, women hygiene, showers, shampoos, clean clothes, blankets for dogs and cats, books for reading, shoes, etc. In N Out Burger provided food. She said that we need stakeholders to bond with us. Foster care youths are put out of the system at age 18 with no family support and ending up on the streets or in human trafficking. The City has a lot of unused properties that could be used for housing.

M. Resilient Los Angeles – Linda Pruett

She is the representative for Lake Balboa to the Neighborhood Council Emergency Preparedness Alliance, which meets once a month downtown at the Emergency Operations Center. This month the speaker was Captain Ignazi (sp?). The CERT Captain is trying to get caches (78x48x 38) available in all the Neighborhood Council districts for disasters. The supplies inside would be available to CERT members.

The White Paper has been distributed to all Neighborhood Council board members across the city of LA, all city council members and their staffs. A presentation to the City Council's budget and Finance Committee is being prepared to present the Budget Advocate proposals. A set of revenue suggestions on how to increase revenue in the city are being developed. The Budget Advocates met with the mayor last month for 1 hour. Another meeting is to be in the Fall. She will be continuing for another year of a two year term. More people are needed as Budget Advocates.

Instead, our representative will be Shellie Billik, who is a member of the Encino Neighborhood Council and a Board member of the Neighborhood Council Sustainability Alliance. Council File 16-0461 addresses what happens to trees that are removed in public areas. Under that

Council File, instead of planting replacement trees, a developer can just pay a fee. Los Angeles has the second smallest urban canopy in the United States. The Tree People feel very strongly that the fees are inadequate and that no plan is in place.
