- 7. Guest Speaker from Birmingham Charter High School, Dean Nick Halic. LBNC's past Communications Officer, Kristen Fujitaki, saw an LA Times article about Nick and others who graduated from local schools and returned to inspire current students. **Item Tabled**
- 8. Special Topic: Safety on our school campuses by Board Member James Brown, Co-Chair Community-Police Advisory Board (C-PAB) California has the toughest gun laws in the nation. Even with tough gun laws, California leads in the number of active shootings and school shootings. School shootings are counted as those around, and on school campuses regardless if there are injuries or death. Last year there were 47 school shootings on campus in California. In January this committee started holding meetings to discuss gun issues and if parents have been held accountable. In most school shootings the guns are brought from home. The State of California has Penal codes for crimes committed with guns. Gun Safety Laws violations were discussed with LAUSD representatives. Each year a letter is sent home reminding parents of gun safety laws. Firearms are the leading deaths of children and teens. 65 School Police Officers due to LAUSD defunding the LAUSD Police Departments.

BYLAWS - Section 6: Vacancies – Vacancies on the Board shall be filled using the following procedure:

- a. Any "Stakeholder" interested in filling a vacancy on the Board shall submit a written application to the Board, providing that Community Stakeholder is qualified for that particular seat. The Board shall cause the matter to be placed on the agenda for the next regular meeting of the Board.
- b. The Board shall vote on the application at the meeting. If multiple applications for one (1) seat have been submitted, the candidate with the most votes wins. In the event of a tie, a coin toss between the candidates with the most votes shall determine the seat appointment.

LBNC has 1 residential and 1 business seat available. Michael Cortez, has submitted an application for the open residential seat.

I received 2 inquiries regarding the residential seat. One withdrew and decided to attend committee meetings first. The second is Michael Cortez who was past board member on Canoga Park NC, moved to Lake Balboa in Sept 2021, W/Metro 7 years, worked with Cindy Montanez in State Assembly.

Mr. Cortez is a homeowner near Roscoe and Balboa. Grew up in the Valley and attended Cal State Northridge. He works for Metro. He saw a lawn sign for the Holiday Parade and decided to join the Neighborhood Council. Mr. Cortez was asked what his interests were. He responded he likes to work with youth, safety is important, and community engagement.
