



# **Roscoe Bl Bus Lanes**

The North San Fernando Valley Transit Corridor Project consists of an enhanced bus network that will increase connectivity and provide high-quality bus service and transit infrastructure in North Valley communities from Canoga Park on the west to North Hollywood on the east. Primary corridors to receive improvements include Roscoe Bl. Nordhoff St and Lankershim Bl, with additional improvements planned for Reseda Bl, Sherman Way, Vanowen St and Victory Bl.



Bus lanes will be installed on Roscoe Bl from Topanga Canyon BI to Coldwater Canyon Av. The bus lanes will drop between Haskell Av and Sepulveda Bl to accommodate 1-405 freeway ramp operations. The bus lanes will operate in the existing AM/PM peak hour lanes.

Statutory Exemption including the Sustainable Communities Project Exemption (SCPE)

Categorical Exemption (CE)

Negative Declaration (ND)

Mitigated Negative Declaration (MND)

Sustainable Communities Environmental Assessment (SCEA

Sustainable Communities Environmental Impact Report (SCEIR)

Environmental Impact Report (EIR)
