Linda Pruett – concern for the current residents that will be displaced – response: there will be at least a year before any steps towards vacating the property will happen.

Residents: concern for current water and electrical service – Response from owners Hedy and Mark Magna of Hedamar Development: the park infrastructure is from 1945 and it cannot handle the current demands; there will be monetary assistance to help residents move; Next steps: the application is already moving through the city's bureaucratic process.
