- 6. Motion: I move to approve the Lake Balboa Neighborhood Council Election Procedures as approved by the Department of Neighborhood Empowerment. B. McRae - Kane Passed 10-0
- Motion: I move that we amend our budget reducing our office equipment by \$2000 and increasing Facilities by \$2000.

- 7b. Motion: I move that we use Academy Addressing to send out another mailing of our election notification rather than using Walking Man so that it would be sent out via the U.S. Postal Service. Leffert -- Pruett Passed 11-0
