  - a. C. McFarland opens the meeting at 7:36 p.m.
- 2. Roll Call, Adoption of Agenda and Approval of Minutes of the May 6, 2009 Meeting
  - a. I. Tjoe introduces a motion to adopt the agenda. L. Pruett seconds. (10-0-1) Motion passes. C. McFarland abstains.
  - b. S. Leffert introduces a motion to approve the minutes of the May 6, 2009 meeting. L. Pruett seconds. (10-0-1) Motion passes. McFarland abstains.
- 3. Announcements and Reports LAPD, Local, City, State, and Federal Representatives, Board Members and Others, Committee Reports
  - a. Councilman Greg Smith's office representative John Bwarie Movies in the Park takes place next Saturday, June 13. First showing is "Hotel for Dogs." City Council signed the budget, but it is not quite official because of changes needed to make after the failure of resolutions on May 19 elections. Specifics about all programs need to be clarified. - 8. Review of Budget for fiscal year 2009-10 Motion to approve budget Tjoe
  - a. C. McFarland goes over new process for budgeting. First budget for the total annual allocation of \$45,000. A revision of this budget would include the rollover money from last year's budget. The City cannot guarantee how much rollover money the LBNC will receive.
  - b. I. Tioe presents budget, a simplified format.
    - A. Discussion: B. McRae would like to devote rollover funds towards effective outreach.
    - B. B. McRae introduces motion to approve budget as proposed. J. Baird seconds. Motion passes (9-0-2) E. Doxsee and C. McFarland abstain.
- 9. Discussion regarding funding for special EP Committee Meeting Inviting local amateur radio operators Possible Motion Pruett
  - a. L. Pruett introduces motion to allocate up to \$300 for postage and refreshments for special EP meeting later in the summer to which we will be inviting the ham radio operator radio operators in our area. L. Reveen seconds.

Discussion: B. McRae does not know how much benefit the LBNC can get from a small event. The money should be spent on the most effective outreach. The LBNC allocated up to \$500 for last year's event. B. McRae would like to allocate only \$500. The event should be larger than last year because it includes 4 communities. S. Leffert does not believe that \$500 will cover enough. LAPD Boosters, if it is a 501-3C, can apply for grants from neighborhood councils and request a given amount from LBNC.
