Four new building are being put up including two hangers and two office buildings. Expected completion February 2016. Belongs to Los Angeles World Airports (LAWA) and we have no say in it. Clay Lacy expects to add up to 100 employees in the next 5 years.

Natalie Arazi: A) Clay Lacy and NetJet are sources of the noise, stated we have a problem with the noise especially run ups on east side of airport. B) This was brought to the Community Advisory Council (CAC) meeting last Fall, it was already a done deal. LAWA did not give us a chance to protest. **Tom Riley:** representative at Clay Lacy did say they were willing to work with the community.

15. BYLAWS - Discussion and possible action:

Linda Gravani made a motion that only the following changes be made to the LBNC Bylaws Approved 1-26-2014, seconded by Brian Tessier

- 1. Section 1G, Two (2) At-Large Appointed Stakeholder Representatives (ALASR) The Board shall appoint the two (2) ALASARs with a two-thirds (2/3) majority vote. The ALASRs shall be appointed within the first two (2) meetings of the seats being vacant. If a two-thirds (2/3) majority cannot be reached at the first two (2) meetings, a simple majority shall only be required until the seats are filled. In the event of a tie, a coin toss between the candidates with the most yes votes shall determine the seat appointment. The appointments shall remain on the agenda until such time that the seats are filled.
- 2. Section 6C. The Board shall vote on the application at the meeting. If multiple applications of one (1) seat have been submitted, the candidate with the most votes wins. In the event of a tie, a coin toss between the candidates with the most votes shall determine the seat appointment

- Article 8 We have a website and we'll have one physical posting location at Ralph's Market, 17250 Saticoy Street, Lake Balboa, CA 91406 per April 1, 2015 Lake Balboa Neighborhood Council board meeting.
- 3. Article 11 Grievance Process- default is the president or chair of the Neighborhood Council.
- 4. Article 10 Elections We want on-line voting with self affirmation voter verification. That is the default.
- Telephone voting requires a lot of work in creating and recording scripts. You may choose to eliminate the telephone voting options if you believe the community will not use it.
 We do not want telephone voting.
- 6. Vote By Mail If your neighborhood council is choosing on-line voting, would you be interested in voter request only vote by mail paper ballots? Yes.

- 7. Board Vote Structure We are going to maintain the current board voting structure.
- 8. Candidate filing requirements should the neighborhood council candidate be required to take a five-ten minute video training about neighborhood council system and their responsibilities as a candidate? Yes.
- 9. Elected board member seating after the 2014 elections and during the 2016 neighborhood council election town halls board members suggested that instead of the current staggering seating of newly elected board members everyone is seated on July 1. This was to minimize transition issues. Other board members stated that July 1st was too long and they would end up with a lame duck board for several months. We are polling neighborhood councils for their feedback so please select one. Keep the current staggered seating of the board is the existing. For all board member should take office on July 1st. Board members should be seated together in same region and election month: Example March election months all seat together on May 1st. April elections will all seat together on July 1st.
