- A. Lauren Padick Field Deputy Councilwoman Martinez's Office (District #6) 818-778-4999 Van Nuys Movie Night is Friday, August 5, 2016 near the corner of Victory and Van Nuys.
- B. Brian Gavidia, Area Representative for LA Mayor Garcetti's Office, 818-778-4990
 - (1) The Welcome Home Project to engage Angelenos on homelessness needs baskets assembled by stakeholders for families, which can be dropped off at Van Nuys City Hall or participating Fire Stations. The Mayor has allocated \$138 million toward homelessness. We need to make sure it's known what resources are available. Host a gathering on September 17, 2016 for presenting the baskets to the homeless. (2) Clean Streets Initiative training is starting. Neighborhood Councils need to attend. Councilwoman Nury Martinez along with Sanitation will host training Thursday, August 25, 2016 at 6:00pm at Branford Recreation Center, Arleta.
- C. Lynda Levitan, Councilwoman Martinez's Office CSUN has a grant and there will be a discussion tomorrow night and Saturday morning about energy and water efficiency. This will take place tomorrow night at Van Nuys City Hall at 6 pm and Saturday morning at 10 am at Branford Park.

C. Allen Nelson – Outreach Committee – Received a Certificate of Recognition dated October 28, 2014 from the office of Assemblyman Adrin Nazarian.

D. James Brown - Health & Safety Committee

The committee met on July 16, 2016. 23 people attending were certified in CPR. The next meeting will be August 20, 2016 at the Flyaway at 10:00am and will have a special guest from the Mayor's office.

E.**Tom Riley – Land Use Committee –** Applications will be addressed at the August meeting. In October we will meet with Budweiser and find out how they will save millions of gallons of water.

- F. Byron Gutierrez Education Committee An update was given on programs being taught in school including equipment, internet, technology, science fair. We are looking to see how our committee can help schools. We have reached out to Bassett and Cohasset to ask how we can help. Cohasset is rolling out a media program which teaches kids how to safely leverage the internet. There is a lot of opportunity.
- G. Jim Stein Recreation and Parks Committee The next meeting is Tuesday, August 9, 2016 at 7pm at Balboa Sports Complex. We are trying to get recycled water extended by purple pipe to the Dog Park. We were told it would be done in 2017-18. Now we're told it will be done through groundwater replenishment, not pipe. We have prepared a letter to send out.
- H. Ruth Doxsee stated she attended the One Water L.A. stakeholder meeting and On Site Water Treatment meeting regarding recycling water. (1) Budweiser is planning on building its own treatment plant. This sounds good, but it will take 50 years for the recycled water that they plan to replenish the groundwater with to get to where we can use it, as opposed to 2-3 years where the Department of Sanitation will inject its recycled water. So ultimately it would be better if Budweiser did not built its plant; it is doing so for a "green" reputation. (2) We can get recycled water on Tuesdays, 8:00 -11:00 am at the Zoo Parking Lot. Most have a closed container. (3)There will also be a Neighborhood Watch meeting on Wednesday, August 31, 2016 at 7:00pm at Stagg St. School. Linda Pruett is going to be the guest speaker on Emergency Preparedness.

8. PUBLIC COMMENT

A. Susan Perkins and Sandy Logan from National Council on Alcoholism and Drug Dependency.

They will be holding their first conference on March 29 and 30, 2017 at Birmingham High School. They are looking for support from the NC and community for that event. It's a reenactment to be held in the schools of a car accident specifically for students regarding underage drinking, drunk driving, texting and driving. This will be the first time they have had an event in the Valley.

B. Glenn Bailey –

(1) Sepulveda Basin Wildlife Area Steering Committee meeting is the end of September.

- They welcome Ruth Doxsee, and we can designate an alternate to be available for the meetings.
- (2) Neighborhood Council Sustainability Alliance is seeking all neighborhood councils to join the Sustainability Alliance. This would have to be agendized.
- (3) Congress of Neighborhoods is September 24, 2016 at City Hall. Registration starts on August 15, 2016. There will be 40 different workshops.
- C. **Robert Cable** He stated this is his first meeting, he has lived here 7-8 years, and he commented on the problem of garbage on the Orange Line Bike Path.

9. Discussion and possible action – Master Plan 2016/17 – Coordinated efforts between all Lake Balboa Neighborhood Council committees – Target school and immediate surrounding stakeholders.

The master plan was discussed by Linda Gravani including school, health and safety, Map your Neighborhoods, Rec & Parks and completion of projects. We should get the community involved around schools. At each elementary school we are trying to find out the needs for that specific school and to reach out to stakeholders to get them involved. We have a vested interest in our schools. This would give us a plan we can work with and will identify future NC members. Also, each committee should select City Council committees to watch so that we know what's coming down the pike. We need to be ahead of the game.

Kristen Fujitaki and Cindy Kurland were appointed to the Ad Hoc Newsletter Committee by President Linda Gravani. The newsletter will be published every month. Possible new options for printing newsletters are being addressed.

11. Appointment of Ad Hoc Database Committee

Kristen Fujitaki and Byron Gutierrez were appointed to the Ad Hoc Database Committee by President Linda Gravani. Previously we had about 800 names. Nation Builder gave us 3,000 with e-mail addresses but there are about 20,000 with no e-mail addresses. We are looking at ways to try to reach stakeholders without the e-mail addresses.
