F. Rosalba Gonzalez, Senior Field Representative from Senator Fran Pavley's Office Dist. #27 818-876-3352

The legislation session ended August 31, 2016, which was the end of Senator Pavley's 14-year tenure in Sacramento. SB32 (cap and trade) passed and will be signed by the governor, which will be part of Sen. Pavley's legacy. Locally, SB887 (response to gas leaks) passed.

5. Guest Speaker Adrin Nazarian, California State Assembly member

He gave an update on the legislative year. A lot has been accomplished. A transportation deal could still be hammered out up to November 30. Transportation issues need to be addressed so that we can move on to housing. We need to address affordable housing and homelessness. We are still feeling the pain of the economic debacle and haven't yet addressed the issue. The minimum wage was passed – California is the first state to implement the \$15 minimum wage. We have to be

mindful that businesses need to keep their doors open, while at the same time people need to have disposable income to make purchases. The farm worker overtime bill was passed as well. We pushed for 1000 homes to be able to receive a \$3,000 grant to bolt the homes to their foundations. We received \$3 million last year and fought for more. We pushed for \$10 million for an earthquake early warning system. We need \$40 million. Also we pushed for \$10 million for loans to seismically retrofit properties. This would be a revolving loan fund.

Assemblyman Nazarian then addressed the Lake Balboa freeway signs. We want the community to have a sense of pride. We found a wonderful partner in Galpin Ford and the Boeckmann family. The new freeway sign was unveiled.

Bert Boeckmann, Galpin Ford – He stated that he used to live in Lake Balboa and he is happy to give something back to Lake Balboa.

A photograph was taken of the Board with the new sign.

A. EP Committee – Sandy Joseph

They are working with CERT in the schools. No EP meeting Saturday, September 10, 2016 due to the 30th Anniversary National CERT Conference starting September 8, 2016. Linda Pruett and Sandy will be attending. The National Conference will be attended by 850 people, FEMA, and program managers and instructors from all over the nation. The Valley Disaster Preparedness Fair will take place on Saturday, October 1, 2016 at Fire Station #87, 10124 Balboa Boulevard, from 10:00am-2:00pm.

B. Health and Public Safety Committee – James Brown

James will be following the Public Safety Committee of the LA City Council. At the August 20, 2016 meeting of the Health and Public Safety Committee there were 30 in attendance for the CPR Classes – 415 have successfully trained in CPR to date. Assembly Bill 1719 (which would require all high school students to take CPR training) has passed the legislature. The next meeting of the Committee will take place on October 15, 2016 and will incorporate training for all ages. In November the Committee will be partnering with the Northridge Neighborhood Council conducting CPR training for that council.

C. Land Use Committee – Tom Riley

Budweiser will speak at the October LBNC meeting on water conservation. Budweiser is the largest employer and landholder in Lake Balboa, and they use the most water in the Valley. They want to work with us. Elections are coming up in November and March. There are 2 land use initiatives on the ballot, one in November and one in March. At the Committee meeting in October we will have speakers on both initiatives.

D. Education Committee – Byron Gutierrez

LAUSD just started. The Committee's intent is to engage with the PTA's. We hope we can identify the target schools to make a difference.

E. Recreation and Parks Committee – Jim Stein

Representatives from Recreation and Parks attended the last meeting and talked about the condition of the facilities in Lake Balboa, limitations because of budget problems, and specific needs and concerns that stakeholders have. Further information will be provided in the Newsletter.

F.

Business Committee – Karen Schatz

ERaD has changed its name to the Business Committee. There will be a change in the focus of the group to support the businesses in Lake Balboa. Perhaps we might poll local businesses as to how to improve the business community. Businesses are interested in our involvement.

G. Outreach -Allen Nelson

Magnolia Science has approached us. They are having an outreach to the community. We will be there. There will be a free table, free food, and flu shots. There will be a Lake Balboa Neighborhood Council booth at the Disaster Fair. Board members should attend.

H. Ad Hoc Newsletter Committee – Kristen Fujitaki

The first newsletter was distributed electronically by email and 500 were printed, available at Ralph, Food for Less, Vallarta, Mama's Donuts, and the Korean Market.
