4. RECEIVED Announcements and Reports by LAPD, Local, City, State and Federal Representatives A. LA City Attorney Raffy Astvasadoorian

He gave an update as to changes to the law. New Municipal Code Section 85.02 makes it illegal for people to live in their cars in some areas and allows it in other areas. Google lamc85.02/westvalley for a map as to where it is legal to live in vehicles. Generally no one can live in their vehicle within 500 feet of a park, school and certain other areas. Also, Municipal Code Section 42.00 decriminalized selling on the sidewalk. It's going to be regulated and permitted. A lot of work has been done on the Sepulveda Basin. People have been living in the flood channel. Now the City is making it available for water to flow through. Raffy was asked if there was a change to food trucks parking along the street (now they can park as long as they want) and how the City was able to take down live oak trees on Burbank Boulevard. He said that all laws were followed.

B. Dr. Margaret Kim – LAUSD Local District Northwest

LA Unified School District is divided into six geographic areas. Lake Balboa is in the Northwest. The LAUSD thanks the LBNC and President Gravani for their support. Bassett St. Elementary School and Mulholland Middle School are state champions for robotics, and they are moving on to the World Competition in Louisville. Steamfest took place on March 4. Linda Gravani stated that when we have Movies in the Park our plan is to have representatives of each of the schools present so that parents can meet them. Dr. Kim agreed with that plan.

6. ANNOUNCEMENTS and REPORTS: Committee Chairs and Board Members

A. President – Linda Gravani

The City Council meeting will be meeting on Friday, April 7, 2017 at Van Nuys City Hall. Thanks to Jim Stein for going all the way downtown to pick up the new credit card. However, the credit card was not connected to Office Depot so he had to pay over \$400.00 to get his work done. There is going to be a roundtable on NC funding today or April 10 at 6 p.m. in Pacoima. The Health and Public Safety Committee won a "Best Of" award at the Valley Alliance of Neighborhood Councils. Regarding the webmaster, we have heard nothing from the Mayor, Councilmember Wesson, or Councilmember Martinez.

B. Emergency Preparedness Committee - Linda Pruett and Sandy Joseph

The CERT Class started in March is going great. The next EP meeting will take place on Saturday, April 8, 2017 at the Flyaway at 9:00am. The speaker will be Mr. Tomlinson who will speak on what to do if faced with an active shooter.

C. Health and Public Safety Committee – James Brown

In February we did an active shooter event. On April 15 we will have a free community training class on CPR. Last year we certified more than 600 people, and this year we are shooting for 1000. Our Committee was awarded a "Best Of" award from the Valley Alliance of Neighborhood Councils.

D. Homeless – Karen Schatz

There was a "homeless" meeting in the Valley but coming up will be Civic U, to be held downtown for homeless issues. We will learn the Mayor's plans and how Measures and H will be implemented. Karen plans to attend with Mary Pennomon and will report back to the Board.

E. Land Use Committee – Tom Riley

In January a community member came to us regarding the asphalt pile. We had a meeting with the community in February. City representatives came in March and answered the questions of the community. The City/community relationship was bridged. Recently we received notice that Vanowen would be paved between White Oak and Andasol. We asked if it could be done during spring break so as not to interfere with the schools. Once again Land Use bridged the gap.

F. Outreach Committee – Allen Nelson

At the last Outreach meeting the new representative from Nazarian's office attended. Blankets of Love, bus bench signs, and Healthy Kids were discussed. It was decided that Lake Balboa will not participate at Veg Fest this year. The Spring Egg Hunt is Saturday, April 8, 2017 from

L. Sepulveda Basin Wildlife Areas Steering Committee (SBWASC) – Ruth Doxsee

- There will be a cleanup of Haskell Creek in the vicinity of the wildlife area on Saturday, April 8, 2017 beginning at 8:30am.
- On Saturday, April 15, 2017, FOLAR's Great LA River Cleanup will take place from 9:00am to noon at the Sepulveda Basin at Balboa Boulevard.
- Army Corp of Engineers update: The rangers still have not been hired but it is still planned, hopefully before the start of their new fiscal year that begins Oct. 1.
- Fishing in wildlife lakes is still a big problem. Fishing is allowed at Beilenson Park and in the summer in certain sections of the LA River but **NOT** the wildlife area.
- A motion to reconsider allowing the LBNC and Encino NC representatives to vote was passed and will be on the May 30 agenda.
- The National Park Service via the Urban Wildlife Federal Partnership is installing cameras along the LA river to get photos of wildlife. They are asking for nonprofits or volunteers to "Adopt a Camera" by checking on them, changing batteries, removing the memory card and uploading photos to NPS. FOLAR is adopting three. Ruth would like a volunteer from the LBNC to take on this task with her.
- The Mayor's office has asked the Mountain Recreation and Conservation District to do a river homeless survey.

M. Youth Affairs - McKay

She went to a couple of schools and spoke to representatives regarding issues they are having with homeless families, trying to get them placed. She contacted a teacher at Birmingham where students come up with what they think is important to their community. She informed the schools that Lake Balboa Neighborhood Council is here and ready to help with issues.

N. Liaisons – Animal Services – Jennifer Freel

LA Animal Services Wildlife Division is doing workshops at shelters, April 6 at North Central, April 20 at West Valley, and May 25 at East Valley. The website for information is laanimalservices.com/wildlife workshops. There is also a handout regarding coyotes in the area and keeping pets safe. There will be a liaison meeting on April 17 in Highland Park and an Animal Services board meeting at East Valley on April 25.
