# 4. President's comments on Minutes for May 3, and May 27, 2017

Linda Gravani referenced Government Code Sections 54950-54963, and read Section 54954.2(a)(1). She also stated: "Since the May 3<sup>rd</sup> meeting was the last opportunity for LBNC to spend as much of the remaining \$42,000 provided by the City of LA, there were a lot of funding items. Not knowing which items would be approved or not, the agenda was written in a way to capture whatever money was left in the budget and still provide the community with what we wanted to achieve. Each item was discussed with time for questions and answers before the final vote as required by Rosenburg's Rules of Order. After the meeting a complaint was filed with the Dept. of Neighborhood Empowerment (DONE) and we were requested by DONE and the City Attorney to redo the funding items because of that complaint. Trying to be conscientious, I wanted to know why our agenda was not correct. I asked for documentation several times as to where I could find the requirements. No Answers. I scoured the official Treasurer's Handbook. I looked through Empower LA's website as well as the City Clerk's website since they now handle NCs funding. I could not find a procedure or policy to guide me. In order to get the funding processed, I used the suggested example forwarded to me by LBNCs Neighborhood Council ADVOCATE. LBNC Board Members attended a special meeting held on a holiday weekend to comply with the unwritten rules. I do want it on record that at no time was LBNC trying to embezzle funds or use them inappropriately. We just wanted to spend all money that was available to us for the good of our community. Extraordinary amounts of time were spent on this issue by the Treasurer, Jim Hart; the 2<sup>nd</sup> Signer, Jim Stein and myself."

- B. Barry Stone DONE The Strategic Budget must be sent through a portal on the monthly statement. Greg Good and Ben Winters from the Mayor's office will be coming to VANC on June 8 to get feedback on CF #17-0274, affordable housing linkage fees. The Department is getting new blood involved in the Neighborhood Councils. DONE needs help contacting business and organizations so a training session can be set up to teach them about the Neighborhood Councils.

# 5B. Guest Speaker Ata Khan, Planning Assistant Community Plan Group

He is with the City Planning Department. He discussed community planning. LA has a general plan, part of the City charter, which is a blueprint for growth. One chapter is land use. LA has 35 community plans. They have not been updated. Ours hasn't been updated since 1999. The Mayor and Council instructed City Planning to update all plans within 6 years. That is a tall order. There are 5 cluster teams. Ours is the Southwest Valley team. Our hope is to bring the current plan up to date. The plan predates Neighborhood Councils. Lake Balboa sits in 2 community plan areas, so we will have to do 2 plan updates. How does Lake Balboa envision growth? There will be a series of workshops. The Lake Balboa workshop will take place July 25, 2017 at Birmingham High School. The website is swvalleyplans.org. If we want a name change to the community plan we should say so. On June 17, 2017 the Department will be doing Planning 101 for the Southwest Valley.

**Sharon Brewer** - She discussed a program called Finders Keepers that Animal Services is working on. A person who finds your animal can keep it and doesn't have to return it. There is an article in City Watch by Phyllis Duarte. Neighborhood Councils should be aware of this.

# C. Health & Public Safety - James Brown

On May 13, 2017, we trained and certified 18 NC and community members in Reseda. On May 20, 2017, we held the usual Lake Balboa class and trained and certified 20. We presented Daniel Pearl Magnet High School with their own AED. On June 12, 2017 with West Valley LAPD we will start training citizen volunteers on patrol to help the LAPD. On June 17, 2017 we will be doing Lake Balboa CPR training. June 1 through July 4 will be "fireworks safety days." On June 24, 2017, we will be doing a Lake Balboa Neighborhood Watch meeting at West Valley LAPD in anticipation of July 4. We will be discussing what neighbors can do to mitigate fireworks, and will hand out Neighborhood Watch signs. A first aid trainer will be there.

#### D. Outreach Committee - Allen Nelson

The mural was painted on May 13-14, 2017. There was lots of coverage.

#### E. Ad Hoc Database – Byron Gutierrez

He needs volunteers to help with the database.

#### F. Ad Hoc Education –Byron Gutierrez

He made a powerpoint presentation focused on helping the Lake Balboa schools. The committee pursued 3 programs for the schools: chess, Go, and robotics. Chess will easily be approved, as Assemblyman Nazarian supports it, and we have buy-in from the schools. Go is a little harder. There will be a congress in San Diego in August. Robotics will be high effort, high impact. We need to reach out to engineers. We should be able to get coaches. We will leverage contacts in other LAUSD schools.

# H. Ad Hoc Recreation & Parks - Jim Stein

The Kids Fitness Challenge for elementary school kids will take place on June 17, 2017 at the Balboa Sports Center. Linda Gravani stated that Movies in the Park was a great success and she met a mentor for the chess program there.

#### I. Sepulveda Basin Wildlife Areas Steering Committee (SBWASC) -- Ruth Doxsee

Only 4/7 members were present and the motion to make NCs voting members of the committee was tabled.

New homeless encampments have sprung up and the committee will communicate with the Army Corps of Engineers (ACOE) to get them cleared.

Unpermitted Raves (loud parties) are still occurring in the Basin. RAP doesn't shut them down due to lack of resources. West Valley LAPD is in charge of enforcing violations of smoking, drinking and parking and these need to be called in as much as possible to force enforcement. Neighborhood Councils need to let Councilwoman Martinez and the rest of the Council know that the basin needs a ranger presence.

# J. Youth Affairs – Madeleine McKay

She will be meeting this summer with the peer mentoring group that educates students about sexual assault. She wants teenagers in the community to know they can make a difference. She stated she has a contact at Birmingham who arranges events and organizes groups for outreach projects if anyone wants to have a meeting there.
