An Easter egg event will take place on Saturday, March 31, 2018 from 9:00am-12:00pm at the park next to West Valley Police Station. An update was given on crime in the area including 4 robberies, 2 aggravated assaults, 14 burglaries, 13 auto thefts, 13 burglaries from motor vehicles, 12 thefts. Overall crime is down from last year.

B. Marcos Sanchez – Field Deputy, Councilwoman Martinez's Office (CD6)

Homeless Connect Day will take place on March 15, 2018 at 10:00am-1:00pm at the Sepulveda Basin. We're making sure that Sanitation and LAHSA should have all the resources they need. A motion in committee has been passed to augment the Hope Team, consisting of LAPD, Sanitation, and social services to address the homeless situation. There is a backlog of 3,000 requests. They are trying to get the money to address 1,900 of those requests. The committee has asked for \$800,000 in overtime for Sanitation. Each council office will get additional days for cleanup. A lot of the homeless in the Basin are service-resistant. The funding for services is kicking in on H and HHH. LA Family Housing is providing housing vouchers. The Council is discussing allowing motels to be part of transitional housing.

housing, electricity access, haircuts, showers, In-N-Out, breakfast. A speaker will be provided on
permanent supportive housing, and perhaps the NC can visit one, maybe the one in Sun Valley.
The Mayor announced a plan for Resilient Los Angeles: Every department within the City is
directed to appoint one liaison to help prepare for any emergencies.

A. President Update: Linda Gravani: Mulholland Elementary School is going to compete at VEX in Kentucky for the second year. They are looking for donations. They need \$16,000 to make the trip. Last year the LAUSD paid for it. Linda will see if they will pay for it once again. Byron Gutierrez, Linda Gravani and Kristen Fujitaki are meeting with Kelly Gonez on March 15th. B. Education Committee – Byron Gutierrez

The Education Committee took on the initiative to support local elementary schools for robots, chess and Go. We are hoping to get chess started again. We have funded 3 schools for chess. Assemblyman Nazarian is funding a chess tournament. Go had to be put on hold because we took on too much. Robots are the big win. We gave 2 of our schools 12 robots each, and we added Gault for 12. Bassett is the furthest along. We also do a lot with Mulholland, which is the only robotics magnet in LAUSD. We need to keep building the STEM program.

Ramon Escobedo, a STEM and robotics teacher for Gault, thanked the NC.
