New Funding Policy:

NCs will no longer be able to sponsor food or refreshments for events they are co-sponsoring. Meaning, if an outside entity (even if within the City family) is hosting an event and asks the NC to sponsor refreshments, the City Clerk's Office will deny it due to the fact that it is considered "gift of public funds." This does not mean that NCs cannot sponsor any food or refreshments for events they are partnering with other organizations, but what it does mean, NCs will need to submit the Event Form. Events Check list which will require permits for right of entry to the venue AND they will need to submit the Events Approval Form. Essentially, it's all in the wording. The NC will need to articulate how they are participating in the event. A simple sponsoring of food will not suffice. NCs will no longer be able to affix a sticker with NC logo and contact information for items they want to give away at community events. No more Back to School backpack giveaways, no more homeless hygiene kits, no more holiday toys ,no more Thanksgiving dinners, no more emergency kits. These items are considered "gifts of public funds." However, NCs are still able to purchase promotional items ordered with the NC logo embossed/engraved etc. on it.

- 8. Guest Speaker Clean Streets Clean Starts Don Larson, Clean Streets Clean Starts is a program that focuses on getting homeless people back to work. It is a 6 week program that is twice a week/3 hours a day. The goal is to cleanup a one mile stretch, paint and trim, while picking up homeless people along the way. The participants are paid a small stipend of about \$25.00 per day which is given in the form of a gift card. The homeless workers are provided a free meal. Good workers are recommended to Hope of the Valley and LAHSA. The program works with about ten people a day; they can take as many as fifteen workers per day. This program coordinates with the City of Los Angeles Department of Sanitation when needed. When Mr. Larson sees people are willing to work and are interested in improving themselves he helps them receive services. Mr. Larson has done cleanups in Sun Valley which is one of the worst areas. Porter Ranch does not have very many homeless. The program is being expanded into other areas. It is run by volunteers. There were questions in regards to their 501c3 status and their revenue of about \$75,000.00 a year.
