President Gravani announced the purpose of Neighborhood Councils by reading from the *Los Angeles City Charter Section 910* Monitoring *of City Services*. President Gravani said that Lake Balboa NC purchased video equipment to video our guest speakers and post on our website. She also announced that after the speaker, the Board will discuss how they would like to react to that presentation. Our job is to get the City to do its job.

L.A. City Charter Sec. 910. Monitoring of City Services.

Neighborhood councils shall monitor the delivery of City services in their respective areas and have periodic meetings with responsible officials of City departments, subject to their reasonable availability.

6. Guest Speaker - from Sepulveda Basin Wildlife Area Steering Committee, Board Member of ENC and Committee member of ENC RaP Committee- Patricia Bates, Ph.D. Treasurer & Homeless Chair of the Encino Neighborhood Council. Patricia Bates holds a Ph.D. from the University of Arizona in experimental psychology and zoology. She has been associated with the San Fernando Valley Audubon Society and the Encino NC Parks Committee for many years. Along with our LBNC representatives Ruth Doxsee and Cindy Kurland, she represents Encino NC on the Sepulveda Basin Wildlife Areas Steering Committee, which is comprised of volunteers from environmental and community organizations dedicated to protecting our wonderful Sepulveda Basin resources.

The Sepulveda Basin, consisting of 2031 acres, is an amazing resource: the 6th largest city-owned park in California and the 46th largest in U.S. Reseda Park is smaller but also a haven for migratory and non-migratory wildlife. They are havens in the midst of a large urban area. As a member of the Wildlife Steering Committee, we're approached frequently to deal with issues and problems in the Sepulveda Basin. There is a ban on fishing in the basin because birds get caught up in fishing lines. There are people hunting birds and gathering duck eggs and homeless issues in the Bowl Creek area. The law enforcement in our City parks is a patchwork since the General Services police were disbanded. We have some park rangers and their base is in Hansen Dam. It takes them over 30 minutes to get to the Sepulveda Basin. We need them at the Basin at all times to explain why people should not gather duck eggs. We have been asking for this for at least 5 years. Councilman Koretz said he would get this in the budget. It is time for the Encino and Lake Balboa and Reseda NCs to push the City to get a dedicated ranger station in our area to cover our basin and parks. She caught two men catching birds for the bird market. These are migratory birds and they need to be protected. Dr. Bates asked the Board to pass a resolution that we need a dedicated park ranger station.

7. Discussion and possible action regarding dedicated park rangers - Gravani 10 min Discussion: Recommend that Lake Balboa send a resolution that we want more than one park ranger in the Sepulveda Basin and that rangers need to be able to write citations. When LAPD goes there, it is not their territory. If word gets out that people are cited then the illegal activities will stop. Nury Martinez, Bob Blumenfield, and Paul Koretz did get an enforcement motion, but it is not being enforced. Federal Rangers are patrolling only the south reserve that is south of Burbank Blvd. They are there to protect the dam. Rangers need an office and dispatch schedule. They need to be visible and talking with people, educating them. They need to be here and at Reseda Park and the Wildlife reserve. In 2008 the budget cutbacks decimated L.A. City Recreation and Parks. They say they are hiring people back, but the rangers are at Hansen Dam and Griffith Park. It takes over 30 minutes for a ranger to arrive and by that time the wildlife have been killed, stolen or severely injured. Lack of rangers and enforcement is the same run around we received when we tried to secede from the City over 15 years ago. Lake Balboa needs to take the lead and Encino and Reseda NCs can follow if they choose. This issue has been discussed in the past and sending a resolution is long overdue.

Boardmember Brown expressed concern about voting for this without knowing the cost.

- 9. ANNOUNCEMENTS and REPORTS: Committee Chairs and Board Members
 - a. **President Update:** The new board retreat will be 6-1-19. There are 43 pages of lobbyists who have registered in 2019 so far. We are 17 people, and are the lobbyists for Lake Balboa. Nury Martinez will be our guest speaker next month. There will not be an election if no seats are contested. Lake Balboa NC has 6 residential seats, 3 business representatives, 3 organizational, 1 youth, 1 senior, 1 at large and 1 at large appointed. We must have 9 people on the Board to have quorum. It is difficult to get people to serve on the NC. Apparently the fun we are having is not getting through.

Mulholland Middle School is holding a career day on Feb. 22, 8:30 am-12 noon. Mulholland has become a film production, bio technology, and engineering magnet school. There are also police cadets at the school. This is our only true middle school. Gault Street School started a GoFundMe account to form a nonprofit to keep 21st century essentials such as their computer lab and a computer aide in the school.

- b. Ad Hoc Education-Gutierrez: Bassett is again trying to become a magnet school and seeking a letter of support. They have a robotics program that has done very well. Gutierrez will participate at the Mulholland Career Fair.
- c. Emergency Preparedness -Pruett: This coming Saturday is the monthly meeting at the Flyaway. 4th in our series of DVDs will be on suturing and stapling and how to take care of big bad wounds. Emergency Preparedness meetings are held on the second Saturday of the month at the Van Nuys Flyaway. The meeting starts at 9:00AM. 2nd floor community room. Parking out front. Last Saturday's shredding event was successful. The next one is on 2/23 10 a.m. 12 noon at Stagg Street School, 7839 Amestoy. Promoting on NextDoor and Facebook. Note: LBNC's Emergency Preparedness bin is located there. During the shredding event we got 39 names. We shredded a lot of paper and met a lot of our stakeholders. Cost was \$250. Normally the charge is \$365. Comments: Shredding event a great idea. Ms. Schwering suggested holding the event a week or two later so people could find out more. There will be a 3rd shredding event March 2nd and a 4th at the election on May 19, 2019. We have these flyers that tell people what we do. We're trying to get candidates so we'll have a board quorum from these outreach efforts. We're trying to do a newsletter and include the shredding event.

- j. Sepulveda Basin Wildlife Areas Steering Committee (SBWASC) Sepulveda Basin Wildlife Areas Steering Committee-Ruth Doxsee/ Cindy Kurland: Attended meeting on 1/22. There will be a Haskell Creek cleanup April 13 in the morning, and this event will get muddy and dirty. Speaker, Steve Dunlap, spoke on invasive pests that are in the super tankers from overseas and they breed like crazy. They are attacking our trees. It is a bigger problem than the drought. They come from outside the country and Mexico. Meets 4th Tuesday of odd numbered months at Balboa Sports Complex 6:30PM. Doxsee/Kurland. - k. Youth Affairs-McKay: At Daniel Pearl, on Fridays the school band comes out once a month for the community and there's a BBQ. Ms. McKay wants to do a student senate. Daniel Pearl has been much more receptive. We talked about a student senate event and pairing it with a BBQ. We also talked about going in to the parks and offering help to homeless people. How can we do this in a safe way will be explored.
- Ad Hoc Election Committee –Schatz: Thank you to the existing board. Everyone needs to register as a candidate. There will be a Rally in the Valley on 2/9. Haven't responded about a table yet. It is a chance to recruit people and let people know what we do. Event is 10 am-2 pm. Chair: Karen@lakebalboanc.org Committee: Cindy Kurland and Mary Pennomon. There are 8 regions and some have already opened their candidate filing. Why doesn't DONE have Spanish posters yet?
- m. Homeless liaison --Kurland/Schatz: Homeless census by volunteers held recently. Ruth volunteered.
- n. **Resilient Los Angeles liaison-Pruett:** The meeting last week was poorly attended. It was on CERT, not resilience. Each NC is supposed to be putting together their plan. LBNC has been ahead of the curve, thanks to Linda Pruett.
- o. Volunteer Police- Pennomon We haven't gone out on patrols because of the rain and liability.
- p. Boardmembers: Ruth Doxsee: The homeless count was pretty painless. One was the navigator and one the counter. I don't think we should have LBNC Committee meetings next time during that week. We all need to participate on those evenings. Also, I attended the meeting of the L.A. County Board of Supervisors and spoke in favor of adding beds to mental health hospitals. Everyone should see the sheet on how to report homeless living on the street. Question by Pruett: Did they actually count the homeless in Lake Balboa. They did it by census tracks. Walked a small part. Mostly circulated by car. Kristen: In the middle of updating the website, send photos and items and will work with Aaron Devandry to have it updated.

L.A. City Charter Sec. 909. Annual City Budget Priorities. Each neighborhood council may present to the Mayor and Council an annual list of priorities for the City budget. The Mayor shall inform certified neighborhood councils of the deadline for submission so that the input may be considered in a timely fashion.

10. Budget Advocate-(BA) Updates: (<u>http://ncbala.com/</u>) Newman (Budget Advocate Carol Newman, Budget Rep Linda Gravani)

Carol Newman said the BAs have completed their White Paper. It is used to describe all the reports. We did 30 + departments. There is also a 5-6 page report regarding city services that goes at the front. In total it is about 100 pages. Carol edited all the department reports. We are a lot further ahead this year in getting out the White Paper. It is now complete. We are trying to set up a meeting with the Mayor with the recommendations for each of the departments. Mayor promised a meeting in January but hasn't been scheduled. We will be having a series of town halls. Valley town hall will be in Tarzana. Stakeholders are requested to come and tell us the services they are not getting. City runs a structural deficit. Expenses routinely exceed income. This year so far the City is \$84 million behind where they thought they would be. This is why we don't have any city services. Every single departments. She read all the reports and her question is where the money is going to come from. There is no answer and the electeds want to push off the decision until their terms are over with. BAs will be putting together a mini white paper. We issued a survey trying to get stakeholder input to find out how the departments are doing. Responses were that they are not doing so good. DONE refused to distribute our survey. We got just under 1,000 responses. The White Paper will be distributed via email to all NCs. Comments: Any updates on City Council being investigated by the FBI.

11. Policy Changes to Neighborhood Council Funding Program dated 1.28.19

James Hart: This is the second change since 2016. The City is making it more difficult for us. If you spend personal money we need multiple approvals: authorization to spend the money, and then authorization to reimburse you every time. I will try to get accounts set up with vendors but there aren't a lot of options. Linda Gravani: The policy changes are 48 pages. https://clerk.lacity.org/sites/g/files/wph606/f/NCFP%20Policies%2007.19.18%20Final.pdf Public comment: This requirement should be for bigger amounts of money.

- 12. Discussion of new LA Council Committee assignments Gravani President Gravani gave a copy of the new assignments effective for City Council committees as of 1/23. Committees are where the work gets done at the City Council and you should be aware of where they meet and who's in charge.
- 13. Discussion / Possible Action to request the City Clerk include the email addresses for each legislative assistant and alternate for all committees of L.A. City Council. Gravani: The only way for stakeholders to send their comments to a committee is to email the legislative assistant. So we are looking into it. If you don't know the protocol you don't know. I want to push the City Clerk to request that the e-mail addresses be put on the committee list.

- 14. Land Use: Discussion and possible action regarding APCSV-2018-2184-ZC & env-2018-2185-EAF 17534 Sherman Way 2 family to 9 unit apartment Riley. The developer is proposing a 9-unit apartment complex on two lots with single family homes. They could build 11 units but they are building 9. There is little to fight them with because Sherman Way is all multi-units. We found several things we thought should be done differently and they came back with the new version. It will be a multi story building with a bus stop there. Many park on the side streets. It's difficult because they don't have enough parking spaces for their building. The rest of the parking will be on the street which will compete with the bus stop. They tried to listen to our concerns and correct them.
- **Discussion:** Linda Pruett has been against this development because of the impact on the surrounding neighborhood. Sadly they are within the City requirements. She will vote against this but there isn't anything we can do anything about it. They want to pack in as many units as possible with no concern for the community. Other comments: Bike racks can be traded to take the place of parking space needs. The City needs to do a better job updating the code. It's not the developer's fault

but the fault of the City. For a storage facility they could reduce parking because of bike racks. We have no control over planning in the City of Los Angeles because our former governor took away local control.

- 15. Land Use: Update on Community Plan Riley Mr. Riley gave the following updates: They are redoing the zones to current zoning codes. They are saying my property is RA1. RA1 requires 33,000 sq. ft., so zoning on my property is changed from RA1 to RA9500 which means you have to have properties that are 9500 sq. ft. I don't have enough to split the lot. There is an area on the north side of Vanowen at Andesol that has been designated by the City as a Historic District because the houses in that immediate area still look like when they were built in the 50's. They are coming back to us sometime in the spring. We have opportunities to participate and it appears they are listening to what we are saying. How well is yet to be seen. One of the most important things we've done is to meet with the community planners and discuss the Lake Balboa boundaries. They have said consistently that no decisions are made but we feel they are listening. The southern boundary is Victory and we share the park with Encino.
- 16. Land Use: Discussion and possible action to officially request a location for a Community Center be set aside Stein We've discussed this several times and at one point we got a letter from Nury Martinez saying she would support our efforts to get a community center. This is a required next step to officially request a location. There is so little land left in Lake Balboa. I thought I stumbled across some at 7000 Hayvenhurst Avenue and spoke with Ms. Sanchez. She decided she had something to put there but we don't know what it is. Jim has been asking for a Community Center. We want one in our community.
