To promote more citizen participation in government and **make government more responsive to local needs,** a citywide system of neighborhood councils and a Department of Neighborhood *Empowerment is created. Neighborhood councils shall include representatives of the many diverse interests in communities and shall have an advisory role on issues of concern to the neighborhood.* We are a department within the city of Los Angeles. Mr. Rodriguez was not present. Accordingly, Ms. Gravani moved the meeting to Item 11.

11. Presentation by Bassett Street School regarding their proposed Magnet Program - Principal Christoff 10 Min Principal Christoff Introduced Teachers: Maggie Riley, Ms. Madrid, and Mr. Fred the Resource teacher. Mr. Christoff thanked Lake Balboa Neighborhood Council for their support. Bassett Street Elementary is applying for a Magnet School program. The Magnet program they are requesting is for Communication Arts, Visual Arts, Broadcasting, and Robotics. The Bassett Robotics program participated in the World Robotics Championships in Kentucky. Bassett wants to provide that as magnet specialization. Schools are losing enrollment. Bassett Elementary has been losing about 2 classrooms a year. Magnets bring students back. This Magnet will elevate the entire school. Parents want their children to attend Magnets and Charters. This elementary school is a feeder school for Mulholland Middle School and Reseda High which also have robotics teams. The school is requesting a letter from LBNC supporting their efforts. Ms. Gravani mentioned the Bassett TV program at the school (BassettTV.com) and that Lake Balboa Neighborhood Council would like an article for the educational newsletter that they are producing.

Public comment: Danica (Stakeholder): Is there a time frame for the Magnet? Answer-They are waiting to hear.

Ms. Gravani stated that there are 13 schools in Lake Balboa, 6 Elementary, 1 Middle School, 1 K-12, and 5 High Schools.

12. Discussion and Possible action on whether or not to support Bassett Street School Magnet Program- 5 MIN Gutierrez

Ms. Gravani will write a letter on behalf of the LBNC to support the school being a Magnet. Mr. Riley, Land Use Committee Chair, stated that the Land Use Committee considers the schools and their improvement an asset to the community.

# Ms. Gravani returned the meeting to Item 10.

10. LA's Illegal Fireworks Task Force (created by Council File #17-1421)- Ms. Gravani mentioned that the information for the Council File is available on the back table if anyone would like to send a letter. City Council Files are numbered so the City can keep track of them. The City Council has said there's a huge problem and has established a task force. Last year the Fourth of July was like a war zone in our community. Ms. Gravani stated that the City Council said the LAPD enhanced enforcement strategies including task force would include mitigating efforts which included education and awareness. Want to go to schools to talk about it. Changes need to be made for mobile reporting. Most efficient was to redesign the capabilities of myla311. They will configure the reporting part of the app to include description of suspect, how many, location, high fire zone, describe fireworks (ground, sparklers). James Brown is into this and has wanted this on the agenda for Councilwoman Martinez. Mr. Brown – All fireworks and sparklers are illegal in L.A. The City Council sponsored a motion to ask the LAPD and LAFD to come back with recommendations. In April 2018 the Public Safety Committee had a hearing with LAFD and LAPD asking for community input. We have CIS's that address our concerns to City Hall. There are 34 NCs in the Valley and only 5 submitted a CIS, which is abysmal. LB was the 5<sup>th</sup>. The LAPD commander said that LAPD will continue with education and will begin a campaign in June. Regardless of how you feel, you as a community need to let them know how illegal fireworks impact the community. Increasing fines and penalties is what is needed. Let the Council members know how you feel. In Southern California there are 48 cities where all fireworks are illegal, 38 cities where they are legal. Fireworks won't be declared illegal statewide. Make a difference. When the fireworks were going on a lot of people were complaining on NextDoor. With the wetlands area, Japanese Gardens so close to residential, it is a sensitive area overall. Signs go up mid-June through the 4th of July. LAPD is given a list

of addresses for violators. Write your representatives. Questions were raised as to whether the Lake Balboa area should have an organized Fireworks Event at one of the local parks.
