L.A. City Charter Sec 900. Purpose (Of Neighborhood Councils)

To promote more citizen participation in government and **make government more responsive to local needs,** a citywide system of neighborhood councils and a Department of Neighborhood Empowerment is created. Neighborhood councils shall include representatives of the many diverse interests in communities and shall have an advisory role on issues of concern to the neighborhood.

L.A. City Charter Sec. 910. Monitoring of City Services.

Neighborhood councils shall monitor the delivery of City services in their respective areas and have periodic meetings with responsible officials of City departments, subject to their reasonable availability.

The Restaurant Beverage Ordinance will allow approved restaurants to get their liquor license without community review and input and shrinks the waiting period from 6 months to 2 weeks. The communities are already saturated with alcohol permits. Arleta has a problem with speeders also. These issues are Public Safety Issues. Arleta Neighborhood Council voted against the Alcohol and Beverage Ordinance. There are too many people addicted to drugs and alcohol to allow more permits. Ms. Gravani provided a document that showed what other Neighborhood Councils have submitted Community Impact Statements on this Council File. c. Discussion and Possible action regarding CF 13-1493 - Street Vending / Special Sidewalk Vending District Program. Mr. Ramos spoke about some of the problems with street vending are vendors cooking outside with an open flame, trash getting left behind, filling up neighbors' trashcans, alcohol consumption, sidewalks are blocked, and the vendors don't wear gloves or hairnets. Where do the vendors go to the bathroom? Where do they wash their hands? Why are they allowed to skirt the laws? Where are they supposed to take their trash? There is no cap on the number of street vendors. They shouldn't be allowed to affect Public Health. If everyone is paying cash, how are the vendors paying taxes? Ms. Gravani presented the list of what other Neighborhood Councils submitted in their Community Impact Statements. Concerns were raised about cooking with open flames being illegal, unsafe, and it is not being enforced. Lauren Padick from Councilmember Martinez's office says the city was pre-empted by the State Law. Ms. Padick also stated that the State law does not allow for whole communities to opt out. Only LAPD, LAFD, or the Councilmember can ask for an exclusion zone **Motion to approve CF13-1493 with the same restrictions listed as SVANC.**

The Lake Balboa Neighborhood Council does not meet in July. Ms. Gravani congratulated Lydia Grant for being elected the First Vice President of the Sunland- Tujunga Neighborhood Council. Tomorrow is the 14th Annual Career Day at Van Nuys Airport students from 24 Los Angeles area schools, are expected.

- b. Ad Hoc Education-Gutierrez: Mr. Gutierrez attended the Porter Ranch Neighborhood Council Education Committee meeting this month. They have different problems. Mr. Gutierrez also attended North Hollywood. He is looking to promote the robotics and chess programs. He also contacted Mission Hills Neighborhood Council to purchase robots for their schools.

There were two active shooter events today. Over 250 people have been killed this year. There are other Active Shooter Trainings going on. May 6, 2019 will be the beginning of a Police Training Academy starting at Davis Training Academy in Granada Hills for Community Police Training. The series of classes are for 8 Mondays from 6:00PM to 9:00PM.

- 10. Budget Advocate-Updates: (http://ncbala.com/) Newman (Budget Advocate Carol Newman, Budget Rep Linda Gravani) Budget Advocates last year extended their term by a year. At Budget Day they hold the Elections. Budget Day is an Event held on June 29, 2019 at City Hall. Because of the way the Budget Advocate Bylaws are written it doesn't work well with the fact that some Neighborhood Council Elections are in May and June. Budget Advocates are chosen from the appointed some Budget Representatives that are chosen by their Neighborhood Councils. In June many of the Neighborhood Councils may not know who will be their Budget Representatives will be so the Budget Advocates have extended their terms one more year. The Department of Neighborhood Empowerment is not happy with the decision because they feel that the Neighborhood Councils were not notified. The Budget Process will not change. On Budget Day we will hear from the Elected Officials. If you are not sure how the City's money works this is an opportunity to learn. The City's Budget is \$10 Billion dollars. The estimate is the Budget does not factor in about \$250 Million in other expenses such as pensions and raises. Ms. Gravani feels the Neighborhood Councils may need to do a resolution.
