Mr. Brown gave the update for LAPD. According to Captain Embrich at National Night Out, crime is down 16%. The Volunteer Police Patrols have helped to make the West Valley Division #1 in crime reduction according to City Attorney Mike Feuer. Ms. Pruett added that Ms. Pennomon was responsible for two criminals being caught.

two months to set up four phases of clean up in the Sepulveda Basin- the archery range, the
area that burned, the area around Lake Balboa, and the area south of Burbank Blvd. The first
phase of cleanup started on Monday. Many of the homeless lost most of their belongings.

Stakeholder question- Is there a Stand Down order on motorhomes and vehicles? No one is addressing the problem.

Ms. Padick-There is no stand down order

Stakeholder question- Who locks up the gates at night at the Sepulveda Basin? Ms. Padick-Los Angeles Police Department Security Division, they are supposed to keep them out of the basin but if they arrest the homeless, they are out of jail the next day. Stakeholder stated- When the homeless were interviewed they stated they are coming right back.

Ms. Padick- Commander Hamilton has given overtime for officers to keep them out. Stakeholder- When homeless people ask for housing, they are told there is nothing available.

Ms. Padick- responded that many of the beds available are in Downtown Los Angeles and the homeless do not want to go to Downtown Los Angeles.

Ms. Taylor –responded that the Assemblymember did support the Bill in the beginning There are over 13,000 people living in their cars when the Bill was introduced it seemed as it would help those that were at risk for losing their jobs if they lost their car to impound. Assemblymember Nazarian will not support the Bill unless he agrees with the way it is amended.

- p. Betty Wong-Oyama- Ms. Wong Oyama announced that three new project coordinators were hired in the Department of Neighborhood Empowerment. She introduced one of the new hires Karen Hernandez. The other new employees are Freddy-Cuppen Ames and Jackie Kim. All Neighborhood Councils will need to fill out a worksheet for the NC Reform motions. Neighborhood Councils need to change their voting age to 16 years old and have a Youth Seat. The Department is recommending all Items that say Board reports or any specific Items that are not agendized, be removed from Neighborhood Council Agendas. The Board of Neighborhood Commissioners, has a new President Eli Lipman and a new Vice President Debbie Wehbe. The Commissioner will be holding Town Hall meetings to discuss Boardmember Removal and Censure clauses in the Bylaws and what trainings Neighborhood Councils think are necessary. The first two Town Halls will be on Tuesday, September 3, 2019 at 6:00PM and Wednesday October 2 6:00PM, locations will be announced.

The Lake Balboa Neighborhood Council will be rolling over \$1,412.83. In the 2019-2020 Fiscal Year Lake Balboa Neighborhood Council will have \$43,412.83. Ten Boardmembers of The Lake Balboa Neighborhood Council had their Code of Conduct Expire. The Cornerstone App at the Department of Neighborhood Empowerment is not working. Please try again or watch the ½ hour training video online and sign the electronic version of the Code of Conduct.

The Mayor's office wants all Neighborhood Councils to get involved with Ready Your LA Neighborhood and host a Block Party. The By-laws window is open for submissions until April 20, 2020. The Congress of Neighborhood Councils is coming up on September 28, 2019.

L.A. City Charter Sec. 910. Monitoring of City Services.

Neighborhood councils shall monitor the delivery of City services in their respective areas and have periodic meetings with responsible officials of City departments, subject to their reasonable availability.

7. Guest Speaker Scott Schmerelson: LAUSD Board Member up for reelection 20 MIN

Scott Schmerelson is the Los Angeles Unified School District Board Member for District 3. Mr. Schmerelson recommended that all of the Neighborhood Councils, in his district, have Education Committees. He likes to work with community members and parents directly. He mentioned that he spends most of his time visiting schools and that every staff member at a school, teach the children. Mr. Schmerelson recently worked on two resolutions. One of the resolutions is about safe gun storage. The second is about lockdown drills. There will be two lockdown drills at all schools each year. There will be staff members assigned to each Neighborhood Council meeting in LAUSD District 3. Mr. Schmerelson talked about why you should support the schools even if you don't have children attending them. Funding helps with the upkeep of the schools which helps keep up curb appeal for property values.

Stakeholder comment- The schools do not have the arts any longer. How do we change that? Mr. Schmerelson responded that there is a traveling art program, but these decisions are made by the school committees.

Stakeholder comment- Teachers are not paid to stay after school for enrichment activities. Mr. Schmerelson responded that budgets are decided by committee. Some schools have PTA's. One of the Valley PTA's fundraised over a million dollars last year. He reminded the audience that California is the fifth largest economy in the world and the worst for funding education. Contact him to discuss school related problems. There was further discussion with stakeholders but the conclusion was that there needs to be more communication.

8. Guest Speakers Mike Benedetto, VP from Granada Hills South NC Olivia Naturman from West Hills NC-Regarding Neighborhood Alliance on Homelessness- Fourteen West Valley Neighborhood Councils have created an Alliance on Homelessness. Partners include the United Way and some Elected Officials. They are looking for proactive solutions. They are asking the Lake Balboa Neighborhood Council to become a partner. Last year the Alliance put together four informational forums. In about six months they hope to hold a job fair and a forum on getting more Landlords to accept Section 8 Housing, and an interfaith forum. On Sunday there will be a meeting at 2:00PM located at The Arts and Culture center is located at 18312 Oxnard Street in Reseda. Councilmember Bob Blumenfield is looking for partners to help bring food deliveries to the Safe Parking Center twice a month. They are also looking to put Safe Parking lots at all of the Community College Campuses for their students.

The Southland Regional Association of Realtors now identifies their location as LAKE BALBOA. The City Attorney advised that CPR and Active Shooter training under the auspices of LBNC must stop immediately due to liability to the city. The City has trained 44,500 people so far in how to respond. There is a pamphlet in the back for any organization that would like to be trained, so that their members know what to do in the event of a shooter situation. On Aug 24, 2019 at 10:00AM, at the Reseda Neighborhood Council office there will be an Active Shooter Presentation. Lake Balboa Neighborhood Council can no longer host the CPR Trainings but two outside organizations will now host them. The next meeting of the Health and Safety Committee will be on August 17, 2019 at the Fly Away. A representative from the Emergency Management Department will be there to help you prepare your Neighborhood on how to respond in the event of an emergency.

Pat Bates of Encino Neighborhood Council reported Clean Streets/Clean Starts of the Northridge Beautification Foundation removed 545 shopping carts and 420 bags of trash from the south side of Burbank Blvd. which was generated from the large homeless encampments there.

Tess Charnosky from Supervisor Kuehl's: office urged use of the new Trails APP for Los Angeles County. Go to www.trails.lacounty.gov to download. Army Corp of Engineers, Rangers, Moreno, and Aquas: informed us of the "Handshake Partnership Program" with agencies that lease Corp land or organizations such as National Audubon and Leave No Trace.

Friends of the LA River (FoLar) and CNPS have secured a Santa Monica Conservancy Proposition 1 Grant for Habitat Restoration in the Sepulveda Basin Wildlife Reserve.

Ms. Pennomon has also been Volunteering at the West Valley Detectives Division. One of the important things that people need to know about, are the Senior Scams. One man lost \$20,000.00 with no way to get it back

- b. Ms. Schwering mentioned that she attended the City Clerk Election Feed Back Session. Ms. Schwering would like to see at least a month of outreach done before the window opens for new candidates. There were between 15 and 20 NC's represented at the meeting. They asked for filing to be extended from 30 to 45 days. There were many complaints of Electioneering and it seemed as if no-one was monitoring it. Election locations need to be reconsidered due to parking issues. The Neighborhood Councils agreed that they want Vote by Mail back for the next elections.

Each neighborhood council may present to the Mayor and Council an annual list of priorities for the City budget. The Mayor shall inform certified neighborhood councils of the deadline for submission so that the input may be considered in a timely fashion.

Budget Advocate Updates, (ncbala.com) Newman 15 min (Budget Advocate Carol Newman and Co-Chair of Budget Advocates with Jack Humphreville, Budget Rep Linda Gravani) There were 36 Budget Advocates voted on city-wide by the City's Budget Representatives. There are three Budget Advocates per Region. Their job is to evaluate the City Departments and produce the White Paper. At Budget Day the two Co-chairs resigned. New Co-chairs were voted on. Jack Humphreville and Carol Newman. The Budget Advocates meet twice a year with the Mayor. The Budget Advocates met with the Mayor for their first meeting on July 24, 2019. They discussed the 2020-2021 Budget. There are many issues with the city. Pay to Play, Typhus, rats, and a lack of transparency. The city has been getting an increase of \$380 Million Dollars per year. They also say that the next four years will show a balanced budget, however the Budget Advocates believe that there is a Billion Dollar short fall.
