Stakeholder definition and Youth seats were some of the items. The Bylaws will be updated to reflect these changes. While Youth members will not be voting on funding items, it is still recommended that they do funding training.

- 10. James Brown, Co-Chair Community Police Advisory Board (C-PAB) and LBNC's 1st VP Update on LAPD Reforms. C-PAB meets 2nd Wed of the month. There will be funding and training changes for LAPD. There was a meeting on August 13, 2020 between Mayor Garcetti and 21 CPAB Chairs. Questions were submitted in advance of the meeting. There were suggestions to take some of the funding and placing it in areas to better serve the community. There is no answer to what degree services will be lost. Officers will no longer be doing detail for events. There will be a reallocation of funds. Time spent on Jury Cases will be shuffled so they will be in court in real time not overtime. Officer Morale at WVPD is low. The

Mayor and City Council let them down. Our officers' lives are on the line and we need to make sure LAPD is supported. Due to the demonstrations there will be more reforms to strengthen accountability. There will also be revisions to the Use of Force Policy and Carotid Holds will be stopped. LAPD is open to reasonable recommendations.
