- 8. Guest Speaker: Police Use of Force update LAPD Captain Grimes 31168@lapd.online Captain Grimes gave his LAPD background. Crime is pretty good violent crime is down. Crime rate has increased for Grand Theft Auto. Do not leave the keys in the car. Park it securely if possible or get a Club device. Captain Grimes presented a Power Point Presentation Eight Can't Wait. Police Reform Plan. There are eight recommendations to reduce Police violence.
 - 1. Ban Choke Holds, 2. Require De-escalation, 3. Warning before using deadly Force. 4. Ban shooting at moving vehicles 5. Exhaust Alternatives, 6. Duty to intervene, 7. Use of Force Continuum, 8. Comprehensive reporting.

LAPD has implemented this plan and others like-Teams 2 System- Early warning Computer Systems, reviews Officers records and it sends out a warning on an officer. Police Dogs are no longer trained to Bite. They are trained to bark. Biased Police-extensive Police training, Law enforcement Code of Ethics. In 1990-LAPD had 115 Officer Involved Shootings, in 2019-LAPD 26 Officer Involved Shootings. The ethnic breakdown was 15 Hispanic, 8 Black, 2 White, and 2 Other Ethnicities. 69% were armed with a firearm and 31% fired at Officers. There were 1.7 Million Contacts, 82,000 arrests, and 2,273 Use of Force (.14%) 2.9% of the time some Use of Force is needed. 3 out of 100 people .001% use of Force out of the 1.7 Million Contacts. Jeremy Q/A anything that restricts or impairs ability? No, it works. Steve Leffert Q/A percentage of African Americans 9% of the population are African Americans. The amount of crimes committed crimes are higher among African Americans and more of them have guns. Next week on the October 14th at the CPAB meeting there will be a presentation on this with more information.

Ms. Gravani moved the meeting to Item 10.

9. Guest Speaker: Ms. Kelly Gonez, LA Unified Board Member District 6.

Ms. Gonez gave updates on the pandemic. They are going to open up the schools with a Hybrid Model when it is safe. Some one and one tutoring has already begun. The District has set up a Covid-19 testing program. Staff is currently being tested. The LAUSD Board voted to put Measure RR on the Ballot, the money will go towards improving the school infrastructure and buildings.

Q/A Can we open schools from K-3rd grade? / This is a priority.

Steve Leffert- Q/A How rapidly are the test results available? / Results come between 24-36 hours.

11. Budget Advocate - Updates, (ncbala.com) - Newman Budget Advocate Carol Newman/Budget Rep Linda Gravani. Carol Newman gave her report on the Budget Advocates. BONC had requested that The Department give a report on the Budget Advocates. This report undercut the existence of the Budget Advocates. The Department decided that about half of the Budget Advocates Funds would be swept and given back to City. The CAO said the special funds could not be taken. The Budget Advocates met with the Mayor today. The City is in a financial crisis. They will be short between Three and Four Million Dollars this year. There is an internal fight within the Budget Advocates that is creating a problem and interfering with the work. There will be a Town Hall in the near future. The Budget Advocates are working on publishing papers
