### L.A. City Charter Sec 900. Purpose (Of Neighborhood Councils)

#### Meeting moved to Item 8 Tony Cardenas:

Congressman Cardenas has been able to get 12.5 Million-dollars' worth of projects for his District. The projects focus on Housing, Mental Health, and Youth Development in the North East San Fernando Valley. Starting on July 15, 2021 The Child Tax Credit has been increased. For those individuals who pay taxes and have children from birth through the age of 17. Payments will begin arriving for those that have children five and under in the amount of \$600.00 a month. For children six and over the payment will be \$250.00. The checks will be monthly between July and December. There are income limits and children need to have a Social Security number. This is the phone number to reach the staff at his office 818-221-3718. There are staff that speak Spanish and English and can get help for other languages. Congressman Cardenas represents 700,000 people of all ages in his District.

The United States Supreme Court has removed the Federal Trade Commission's ability to go after Fraudsters. It is the Federal Trade Commission that protects people from Fraud. For over forty years the Commission had the Authority, but in April it was interpreted that it needs to be re-addressed by Congress. He has a Bill in the Senate to restore the ability to prosecute. This issue includes pharmacies and there are no protections at this time for the public. For the first time we have our first Senator born and raised in the San Fernando Valley is Alex Padilla who is a fellow Engineer. There is an upcoming CVS Event, this Sunday. on Roscoe Blvd and Van Nuys from 10:00AM-2:00PM for free Pfizer Vaccines. James Brown asked for the Bill number and how would you prioritize the states funding?
Bill # HR2668. Ca Federal Aid has added \$151 Billion to the states' coffers funding money from Covid
Acts Money before Biden it was going to be Medical only. All Local Governments needed funding from
State and Local Governments. The State will be in the black due to the funds and have a surplus.
Priorities- Make Covid vaccines available, make sure we have enough Medical Personnel,
Housing, Mental Health, Housing Authority.
