- 7. Guest Speaker: Shun Yu Zhang, Bureau of Engineering to brief us on SEPULVEDA BASIN VISION PLAN. The Sepulveda Basin encompasses 2,000 acres between Victory and Ventura and Balboa and Woodley. It was established in the late 1930's. It has a very vast history. The Federal Government bought the land to make the LA River as part of the stormwater management system. In the 1970s clay was excavated to rebuild the Van Norman Dam. The pits filled with water which was used by the birds. The river is heavily channelized. They are looking to make it more naturalized. There is planning going on along the Los Angeles River. A feasibility Plan has been released looking at ways to naturalize it. 1,500.00 is leased by the City of Los Angeles. They are also looking at the big picture including :other parks and open spaces, the amount of housing around the parks, and the environmental burden. Infrastructure funding is available. They need to do water quality improvements. How do we recharge the Aquifer, handle the flood risk management, and fires today, and in the future? They need to protect the eco systems . Transportation, how will people get there? Habitat There will be a series of meetings. There is a meeting scheduled on June 20, 2023 at the Mid Valley YMCA 6-8PM. Take the survey online. At this time the Olympic Events will not be done at the Sepulveda Basin.
- 8. James Brown to discuss WHY EVERY SCHOOL SHOULD HAVE AN AED (Automated External Defibrillator) The CPAB May meeting has been cancelled. The June 14, 2023, CPAB meeting will feature a Candidate Forum for the Council District 6 (CD6) Candidates.

James Brown did a presentation on CPR and the use the AED. He told stories of students who lost their lives on school campuses due to the failure to use CPR and AEDs.

It was successfully lobbied at City Hall for all kids to be trained in CPR. That support helped to get AB1719 passed which makes it a requirement for all students in grades 9-12 to be CPR trained to be able to Graduate from High School. Only 2% of the population knows CPR. His committee has helped 2,500 people get CPR trained. Mr. Brown did a demonstration of how to use the AED.

Avoidable Death-1,000 people a day have a sudden cardiac arrest. Time is of the essence. Within 6 minutes without intervention, they die.

Automated External Defibrillator-70% of Cardiac Arrests happen at home. There is a Paramedic shortage nation-wide. The average response time is 8-12 minutes. With an AED your chance of recovery goes up to 80%. The Lake Balboa Neighborhood Council got an AED for Daniel Pearl Magnet High School. It is critical that every school has an AED. Narcan should also be available on all school campuses in case of Fentanyl overdose.
