Public Comment:

- a. Former Boardmember He is concerned. Once they start building they won't stop. ED1 has to be 100% affordable.
- b. Stakeholder Traffic issues with all of the building, failing infrastructure, lack of Public Safety. The homeless don't care and won't keep up the community. The homeless destroyed 3 new trailers and that housing was abandoned in three months. Hosting the Olympics. What we see are Emergency Powers that keep being used over and over.
- c. Stakeholder 5% of the units will go to homeless people. Overdose rates are up. How can you put them across the street from a school? Decline in property values and lack of public safety need to be addressed first.
- d. Stakeholder Spoke about the history of the area. The parking is going to be an issue and the police can't be the babysitters.
- e. Stakeholder This project is not the answer. This development is a for profit venture and we deserve transparency. There is a disregard for zoning laws and we are being asked to give up safety.
- f. Stakeholder New resident, we were robbed 3 days after we moved in, 2months later our bike was stolen from inside our garage. Now we have had things stolen four times due to the transients. We

- spent six months looking for a home. She would not have spent her life savings to move here and now 194 units are being built in my area and crime is going to increase.
- g. Stakeholder Thank you to all of our great neighbors. It should not have taken this long for our community to learn what is going on. She thanked everyone for showing up and told everyone that they need to advocate. We will not stand for our community being taken over. The Principal of Birmingham High School is here tonight. They were not notified. Tried to speak with Imelda Padilla and does not feel that she cares. We are not going to stop and will fight this every step of the way. The developer should have to pay for us to have permit parking. There is power in numbers.
- h. Linda Gravani reminded the community that all 17 Boardmembers stepped up to help the community. They don't get paid. They all do what they can and they need the communities help. We need you to go to our website and attend our meetings. Ms. Gravani went over the different committees. Ms. Gravani believes that the project can't get funding. This property was purchased with Federal funds. We need everyone to make phone calls.

Community members said they were putting in sewers at 11:00PM. They are using very bright lights at this site.

Stakeholde r- Don't give away information. They will use it against. They are going to take 80 properties to connect to the light rail.
