## Candidate Filing Requirements

Candidates must be stakeholders within the boundaries of the Lake Balboa Neighborhood Council (LBNC) and must be at least 18 years of age at the time of election. Candidates my run for only one office and must demonstrate proof of stakeholder status for the office for which they are running. A map is included for quick reference, but exact area boundaries can be found on our website.

Every candidate must complete the Candidate Filing Form included in this newsletter attesting to the fact that s/he meets the filing requirements. The form will also be made available at the following locations and online at www.lakebalboanc.org

Forms must be received by the Independent Election Administrator (IEA) at the address indicated on the form no later than August 30, 2012.

There will be a Candidate Forum during our regular monthly meeting, September 5, 6:30pm, where candidates will be able to make a short speech (limited to 5 minutes).

#### **Voting Information**

Voting is open to everyone who is a stakeholder within the boundaries of the LBNC. Stakeholders must be 18 years of age at the time of the election, except for stakeholders voting for Youth Stakeholder Representative must be 12-18 years old. In order to vote, a stakeholder must by means of "self-affirmation" declare that s/he is a stakeholder. No further documentation will

be required. Stakeholders may vote for 15 seats currently up for election.

Stakeholders may request a vote by mail (VBM) ballot. The request for a VBM ballot can be made by filling out and mailing the Election Registration Form, included in this newsletter. This form must be mailed to address on the form and received by the IEA no later than August 30, 2012. Completed VBM ballots must be returned in the corresponding numbered envelope by September 28, 2012. A ballot not returned in the designated numbered envelope will not be accepted. Photocopies of ballots will not be accepted.

Stakeholders may also deliver their ballot at the polling place (Van Nuys Golf Course, 6550 Odessa Ave, Lake Balboa) during the election period, which will be Saturday, September 29 between 10am and 2pm. Stakeholders may register and vote a the polling place. No ballots will be accepted after 2pm on September 29, 2012.

#### Your Neighborhood Council

Neighborhood Councils were created in 1999 during the last Los Angeles City Charter Reform as a means of decentralizing local government by encouraging the residents of all the city's diverse neighborhoods to become directly involved with the quality of life issues that affected them. The LNBC Board is composed of stakeholders who meet on a regular basis to listen and respond to the concerns and suggestions of their neighbors. The City is funding the NC system: This fiscal year, LBNC was allocated \$37,000 to support local projects.

#### What is a Stakeholder; What can s/he do?

A stakeholder is someone who lives, works, owns property or claims a stake in the well-being of the community. Stakeholders can attend meetings, participate in committees and have an impact on the decision-making process of the City.

#### What is the LBNC Board?

The LBNC Board is comprised of 17 members representing diverse stakeholder interests. Six Residential (RSR) seats, three Business (BSR) seats, three Organizational (OSR) seats, one Senior (SSR) seat, one Youth (YSR) seat, 1 Elected At-large (ALESR) seat are currently up for election. There are 2 Appointed At-Large (ALASR) seats. Board members serve terms of two years.

### What are Board Members Expected to do?

Board members are expected to attend general meetings and special meetings and participate on committees, conduct outreach in their area by making community members and neighbors aware of the LBNC, and, with the Board, advise the City of Los Angeles on policy issues that affect the community.
