A NEW EMERGENCY RESPONSE THAT USES TRAINED SPECIALISTS, RATHER THAN LAPD OFFICERS TO RENDER AID TO HOMELESS PEOPLE AND THOSE SUFFERING FROM MENTAL HEALTH AND SUBSTANCE ABUSE ISSUES.

CHIEF MOORE SAID: I BELIEVE THAT WHEN YOU TAKE THOSE OTHER TASKS AWAY FROM US (LAPD) AND GIVE THEM TO PEOPLE WHO CAN HANDLE THAT WORK MORE EFFECTIVELY AND EFFICIENTLY, ALLOWS LAPD TO PROVIDE FOR PUBLIC SAFETY WITH IT'S CORE FUNCTIONS.

WEST VALLEY C-PAB MEETING ON JUNE 9TH CAPT. BRIAN BIXLER SPOKE AT LENGTH AND ANSWERED QUESTIONS RE LAPD'S NEW ALTERNATIVE DISPATCH PROGRAM TO HANDLE MENTAL HEALTH NO-VIOLENT CALLS AS THEY OCCUR IN OUR NEIGHBORHOODS:

CURRENTLY, IF A MENTAL HEALTH CALL RECVD BY 9-1-1 IS DETERMINED TO BE SUICIDAL, IT IS FORWARDED TO DIDI HIRSCH (CONTRACT AGENCY) FOR FURTHER DETERMINATION. IF THE CALL IS NON-VIOLENT AND DOES NOT INVOLVE SOME TYPE OF CRIMINAL ACTIVITY- RATHER THAN SENDING LAPD TO RESPOND AND THEN SEEKING THE HELP OF MENTAL HEALTH PROFESSIONALS, LAPD NEW ALTERNATIVE DISPATCH PROGRAM CALLS ON MENTAL HEALTH PROF TO HANDLE NON-VIOLENT CALLS. IF THE CALL IS VIOLENT (PRONE) THEN OFFICERS ARE SENT. – James Brown, SLO Hugo Fuentes

WHAT THIS NEW PROGRAM IS DESIGNED TO REDUCE HOW OFTEN ARMED OFFICERS RESPOND TO NON-VIOLENT CALLS.. THE TEAMS ARE CALLED SMART (SYSTEMWIDE MENTAL ASSISSMENT RESPONSE TEAM) WHICH CONSIST OF MENTAL HEALTH PROF. AND LAW ENFORCEMENT. UNDER THE NEW PLAN, LAPD 24 HOUR TRIAGE DESK PAIRS OFFICERS AND COUNTY MENTAL HEALTH SPECIALIST WILL ASSESS WHETHER TO DISPATCH A SMART TEAM OF NOT. THE IDEA TO TO CUT DOWN ON SUICIDE BY COP.
